Only shortlisted candidates shall be invited for the interview. Mere submission of the application, does not guarantee an applicant to be qualified for the final rounds of interview. The selection shall be purely based on the highest qualification and experiences as deemed suitable by the selection and screening Committee for the post.

## **Duration of Deputation:**

- The deputation will initially be for a period of 3 years on the basis of the recommendations made by the selection committee constituted under the chairmanship of the Secretary, School Education, Govt. of Sikkim and will be renewed as deemed necessary.

## General instructions to applicants:

- 1. The above appointment would be on deputation basis. The selected candidate should be willing to stay in the premises of the Residential Model School.
- 2. Selection process will be through Personal Interview. The Department reserves the right to change/ modify the selection process at any time, during the process, at its discretion. The decision of the dept. will be final and binding.
